There are, unfortunately, no parking opportunities in the area around Alte Feuerwache. Thus, we recommend you to use public transport:

Tram lines: 12, 15, 16, 18 (station: Ebertplatz, five minutes' walk)

Bus line: 127 (station: Ebertplatz, five minutes' walk)

S-Bahn (local train): S6, S11, S12, S13 (station: Hansaring, five minutes' walk)

Regional train: RB 25 (station: Hansaring, five minutes' walk)

If you travel by car left of the Rhine (North/South/West): take the highway A 57 to Innere Kanalstraße in the direction of Zoobrücke - turn to the right into Krefelder Straße at the first cross-roads - turn to the left at the third street (at the

church) into the low-traffic-zone - drive approx. 150m straight-ahead on the Balthasarstraße - turn to the right into the Kasparstraße at the first cross-roads - you will find the entrance of the Feuerwache

If you travel by car right of the Rhine (North/South/West):

Autobahnkreuz Köln-Ost in the direction of Zoobrücke/Zentrum - past the Zoobrücke stay on the left - turn to the left at the first traffic light - follow that street - turn to the left into the Neusser Straße - turn to the right at the second traffic light into the Balthasarstraße - after approx. 100m turn to the left into the Melchiorstraße = you will be at the Feuerwache.
